

- Do not use hoses to pull equipment.
- Route hoses away from traffic areas, sharp edges, moving parts, and hot surfaces. Do not expose Graco hoses to temperatures above 82°C (180°F) or below –40°C (–40°F).
- Wear hearing protection when operating this equipment.
- Do not lift pressurized equipment.

## WARNING



### INJECTION HAZARD





Spray from the gun, hose leaks, or ruptured components can inject fluid into your body and cause extremely serious injury, including the need for amputation. Fluid splashed in the eyes or on the skin can also cause serious injury.

- Fluid injected into the skin might look like just a cut, but it is a serious injury. Get immediate medical attention.
- Do not point the gun/valve at anyone or at any part of the body.
- Do not put your hand or fingers over the spray tip/nozzle.
- Do not stop or deflect leaks with your hand, body, glove or rag.
- Do not "blow back" fluid; this is not an air spray system.
- Always have the tip guard and the trigger guard on the gun when spraying.
- Be sure the gun trigger safety operates before spraying.
- Lock the gun/valve trigger safety when you stop spraying.
- Follow the **Pressure Relief Procedure** on page 7 whenever you: are instructed to relieve pressure; stop spraying; clean, check, or service the equipment; and install or clean the spray tip.
- Tighten all fluid connections before operating the equipment.
- Check the hoses, tubes, and couplings daily. Replace worn, damaged, or loose parts immediately. Permanently coupled hoses cannot be repaired; replace the entire hose.
- Use only Graco approved hoses. Do not remove any spring guard that is used to help protect the hose from rupture caused by kinks or bends near the couplings.



### **MOVING PARTS HAZARD**

Moving parts, such as the air motor piston, can pinch or amputate your fingers.

- Keep clear of all moving parts when starting or operating the pump.
- Before servicing the equipment, follow the Pressure Relief Procedure on page 7 to prevent the equipment from starting unexpectedly.

## **▲** WARNING



### FIRE AND EXPLOSION HAZARD



Improper grounding, poor ventilation, open flames or sparks can cause a hazardous condition and result in a fire or explosion and serious injury.

- Ground the equipment and the object being sprayed. Refer to Grounding on page 5.
- If there is any static sparking or you feel an electric shock while using this equipment, **stop spraying immediately.** Do not use the equipment until you identify and correct the problem.
- Provide fresh air ventilation to avoid the buildup of flammable fumes from solvents or the fluid being sprayed.
- Keep the spray area free of debris, including solvent, rags, and gasoline.
- Electrically disconnect all equipment in the spray area.
- Extinguish all open flames or pilot lights in the spray area.
- Do not smoke in the spray area.
- Do not turn on or off any light switch in the spray area while operating or if fumes are present.
- Do not operate a gasoline engine in the spray area.



### TOXIC FLUID HAZARD

Hazardous fluid or toxic fumes can cause serious injury or death if splashed in the eyes or on the skin, inhaled, or swallowed.

- Know the specific hazards of the fluid you are using.
- Store hazardous fluid in an approved container. Dispose of hazardous fluid according to all local, state and national guidelines.
- Always wear protective eyewear, gloves, clothing and respirator as recommended by the fluid and solvent manufacturer.

## Installation

### Grounding

To reduce the risk of static sparking, ground the pump and all other spray equipment used or located in the spray area. Check your local electrical code for detailed grounding instructions for your area and type of equipment. Be sure to ground all of this spray equipment:

- Pump: loosen the grounding lug locknut (A) and washer (B). Insert one end of a 12 ga. (1.5 mm²) minimum ground wire (D) into the slot in lug (C) and tighten the locknut securely. See Fig. 1. Connect the other end of the wire to a true earth ground. Order Part No. 237–569, Ground Wire and Clamp.
- 2. *Air hoses:* use only electrically conductive air hoses.
- Fluid hoses: use only electrically conductive fluid hoses.
- 4. *Air compressor:* follow manufacturer's recommendations.
- 5. *Spray gun:* grounding is obtained through connection to a properly grounded fluid hose and pump.
- 6. Fluid supply container: according to your local code.
- 7. *Object being sprayed:* according to your local code.

- All solvent pails used when flushing, according to your local code. Use only metal pails, which are conductive, placed on a grounded surface. Do not place the pail on a nonconductive surface, such as paper or cardboard, which interrupts the grounding continuity.
- 9. To maintain grounding continuity when flushing or relieving pressure, always hold a metal part of the spray gun firmly to the side of a grounded metal pail, then trigger the spray gun.




### Flushing Safety

Before flushing, be sure the entire system and flushing pails are properly grounded. Refer to **Grounding** at left. **Relieve the pressure** and remove the spray tip from the spray gun. Always use the lowest possible fluid pressure, and maintain firm metal-to-metal contact between the spray gun and the pail during flushing to reduce the risk of fluid injection injury, static sparking, and splashing.

#### **NOTES**

- If your manual is lost or missing, order a new one at no charge, directly from Graco, Inc.
- Reference numbers and letters in the text refer to the Figures and Parts Drawing.
- Accessories mentioned in the text are available from your Graco distributor.

Use thread sealant on all non-swiveling connections.

Install the casters (30) in the pump mounting stand (40). Loosen the setscrews (28) and lower the pump into the stand until the bottom of the u-fitting (31) clears the floor by 1/2 in. (13 mm). Tighten the setscrews.

Connect one end of the fluid hose (8) to the filter outlet nipple (43). Connect the swivel (1) to the other end of the hose. Connect the spray gun (25) to the swivel. Do not use thread sealant, which prevents the swivel from rotating freely.

Connect a 1/2 in. (13 mm) minimum ID grounded air supply hose (F) to the 1/2 npt(f) air inlet union (37). The main air supply line must include a bleed-type master air valve (E) for shutting off and relieving air pressure in the system. Install the bleed valve at the air inlet, using an adapter for clearance.

## **WARNING**

A bleed-type master air valve (E) is required in your system, to relieve air trapped between this valve and the pump after the air is shut off. Trapped air can cause the pump to cycle unexpectedly, which can cause serious injury from moving parts if you are adjusting or repairing the pump.

Install the air line filter (G) to remove dirt and moisture from you compressed air supply. Downstream from the filter, install an air line lubricator (H) for automatic air motor lubrication. If you supply your own accessories, be sure they are adequately sized to meet the system's air requirements.

Install the ball valve (41) in the bottom of the fluid filter (21). Install the gauge in the air regulator (12) as shown in the parts drawing on page 8.

Ground the pump and spray system as described on page 5.

Read the section **Flushing Safety** on page 5. Then, flush the sprayer as described in the pump manual 306–981 to remove the oil left in the pump after factory testing.

# **Operation**

#### **Pressure Relief Procedure**

## **WARNING**



### **INJECTION HAZARD**

Fluid under high pressure can be injected through the skin and cause serious injury. To reduce the risk of an

injury from injection, splashing fluid, or moving parts, follow the **Pressure Relief Procedure** whenever you:

- are instructed to relieve the pressure,
- stop spraying/dispensing,
- check or service any of the system equipment,
- or install or clean the spray tip/nozzle.
- 1. Lock the spray gun trigger safety.
- 2. Shut off the air to the pump.

- 3. Close the bleed-type master air valve (required in your system).
- 4. Unlock the spray gun trigger safety.
- Hold a metal part of the spray gun firmly to the side of a grounded metal pail, and trigger the gun to relieve pressure.
- 6. Lock the spray gun trigger safety.
- 7. Open the drain valve (required in your system), having a container ready to catch the drainage.
- 8. Leave the drain valve open until you are ready to spray again.

If you suspect that the spray tip or hose is completely clogged, or that pressure has not been fully relieved after following the steps above, very slowly loosen the retaining nut or hose end coupling and relieve pressure gradually, then loosen completely. Now clear the tip or hose.

## **Service**

## **▲ WARNING**

To reduce the risk of serious injury, including injection or injury from moving parts, always follow the **Pressure Relief Procedure**, above, when checking or servicing any part of the spray system, when installing, cleaning or changing spray tips, and whenever you stop spraying.




