

 Pump: check ground wire and clamp for proper installation. To install ground wire and clamp. See Fig. 1. Loosen grounding lug locknut (W) and washer (X). Insert one end of a 1.5 mm² (12 ga) minimum ground wire (Y) into the slot in lug (Z) and tighten the locknut securely. Connect the other end of the wire to a true earth ground. To obtain ground wire and clamp, order Graco Part No. 238–909 Ground Wire Assembly.



- 2. *Air and fluid hoses:* use only electrically conductive hoses.
- 3. *Air compressor:* follow manufacturer's recommendations.
- 4. *Spray gun:* ground through connection to a properly grounded fluid hose and pump.
- 5. Fluid supply container: follow your local code.
- 6. *Object being sprayed:* follow your local code.
- 7. Solvent pails used when flushing: follow your local code. Use only metal pails, which are conductive, placed on a grounded surface. Do not place the pail on a nonconductive surface, such as paper or cardboard, which interrupts the grounding continuity.
- 8. To maintain grounding continuity when flushing or relieving pressure, hold a metal part of the spray gun firmly to the side of a grounded *metal* pail, then trigger the gun.

Setup

General Information

Reference letters shown in parentheses used in text refer to callouts in figure 2. Figure 2 is only a guide for selecting and installing system components and accessories. Contact your Graco distributor for help in designing a system to suit your particular needs. Refer to the **Accessories** section for accessories available from Graco.

System Accessories

A main air bleed valve (L), pump air bleed valve (J), and fluid drain valve (B) are required. These accessories help reduce the risk of serious injury, including fluid injection and splashing of fluid in the eyes or on the skin, and injury from moving parts if you are adjusting or repairing the pump.

The main air bleed valve (L) shuts off and relieves the air to the pump. The pump air bleed valve (J) relieves air trapped between it and the pump after the air is shut off. Trapped air can cause the pump to cycle unexpectedly. Locate the valve close to the pump.

The fluid drain valve assists in relieving fluid pressure in the displacement pump, hose, and gun. Triggering the gun to relieve pressure may not be sufficient.

Supplied Components

The following components are supplied with your pump:

- The bleed-type master air valve (J) is required in your system to relieve air trapped between it and the air motor when the valve is closed (see the WARNING above). Be sure the bleed valve is easily accessible from the pump, and is located downstream from the air regulator.
- The pump air filter/regulator (E) controls pump speed and outlet pressure by adjusting the air pressure to the pump. It also removes harmful dirt and moisture from the compressed air supply. Locate the regulator close to the pump, but upstream from the bleed-type master air valve.
- The fluid drain valve (B) is required in your system to relieve fluid pressure in the pump, hose and gun (see the WARNING at left).

Air Line Accessories

Install the following accessories in the order shown in Figure 2, using adapters as necessary:

- A pump runaway valve (P) senses when the pump is running too fast and automatically shuts off the air to the motor. A pump which runs too fast can be seriously damaged.
- An air line lubricator (G) provides automatic air motor lubrication.
- A second bleed-type air valve (L) isolates the air line accessories for servicing. Locate upstream from all other air line accessories.

Air and Fluid Hoses

Connect an electrically conductive fluid hose (N) to the 3/8 npsm(f) outlet union (D) of the fluid filter (C).

Connect an electrically conductive air supply hose (M) to the air inlet union (F).

Connect a spray gun (R) to the fluid hose.



Pressure Relief Procedure

WARNING



INJECTION HAZARD

The system pressure must be manually relieved to prevent the system from starting or spraying accidentally. Fluid under high pressure can be injected through the

skin and cause serious injury. To reduce the risk of an injury from injection, splashing fluid, or moving parts, follow the Pressure Relief Procedure whenever you:

- are instructed to relieve the pressure,
- stop spraying/dispensing,
- check or service any of the system equipment,
- or install or clean the spray tip/nozzle.

- Lock the spray gun trigger safety.
- 2. Close the pump air bleed valve (J, required in your system).
- 3. Shut off the main air bleed valve (L, required in your system).
- 4. Unlock the spray gun trigger safety.
- 5. Hold a metal part of the spray gun firmly to the side of a grounded metal pail, and trigger the spray gun to relieve pressure.
- Lock the spray gun trigger safety.
- 7. Open the drain valve (B, required in your system), to relieve pressure in the fluid hose and gun. Triggering the gun to relieve pressure may not be sufficient. Have a container ready to catch the drainage.
- 8. Leave the drain valve open until you are ready to spray again.

If you suspect that the spray tip or hose is completely clogged, or that pressure has not been fully relieved after following the steps above, very slowly loosen the tip guard retaining nut or hose end coupling and relieve pressure gradually, then loosen completely. Now clear the tip or hose.

Operation

Flush the Pump Before Using

Pumps are tested with lightweight oil which is left in to protect pump parts. To prevent contamination of fluid, flush the pump with a compatible solvent before using it. Before flushing, always follow the **Pressure Relief Procedure Warning** on page 9, and remove the spray tip from the gun. Use the lowest possible pressure, and maintain firm metal-to-metal contact between the gun and a grounded metal pail during flushing.

Sprayer Startup

- 1. Engage the spray gun safety latch, but do not install a spray tip yet.
- Be sure the fluid drain valve (B), air regulator (E), and pump bleed-type master air valve (J) are closed. See Figure 2 on page 7.
- 3. Place the suction tube (A) in the fluid container.
- 4. Open the bleed-type master air valve (J).

- Release the spray gun safety latch and hold a metal part of the gun firmly to the side of a grounded metal waste container. Trigger the gun while slowly opening the air regulator (E).
- 6. Allow the pump to run **slowly** until all air is purged from the pump and hose and a steady stream of fluid is flowing from the gun. Then release the trigger and engage the safety latch. The pump should stall against pressure when the trigger is released.
- 7. Follow the **Pressure Relief Procedure** on page 9.
- Install the spray tip. If you are using the RAC IV DripLess[™] Tip Guard, refer to manual 307–848 for installation instructions.


NOTE: If the pump is hard to prime, follow steps 1 to 4, place a waste container under the fluid drain valve tube, open the drain valve, slowly open the air regulator, and run the pump **slowly.** As soon as fluid comes from the drain tube, close the drain valve quickly. Now trigger the gun to prime the hose.



Accessories

For Two Gun Systems

Each line in a two gun system must have a shutoff valve to relieve fluid pressure if the fluid line becomes clogged, and to isolate one gun for servicing while the other is in operation. Director valve 214–711 is recommended for both purposes. Use elbow 100–840 to direct the outlet flow from the drain valve in a safe direction to a waste container. Use reducer bushings 100–176 and 100–206 to connect the valve to the outlets of fluid filter 214–625.

In the draining mode, the valve handle is turned away from the elbow (marked DRAIN on the valve housing); in the operating mode, the handle is turned toward the elbow (marked CIRC on the housing).


