NOTICE

- Tighten lock ring (a) securely. If the lock ring is not fully tightened, the pump may be damaged.
- Tighten the uptake locking sleeve (b) securely. If the sleeve is not tightened securely, the pump will draw air though the joint and fail to deliver the full volume of fluid.


