





VARNING



High-pressure fluid from gun, hose leaks, or ruptured components will pierce skin. This may look like just a cut, but it is a serious injury that can result in amputation. Get immediate surgical treatment.



- Do not spray without tip guard and trigger guard installed.
- Engage trigger lock when not spraying.



- Do not point gun at anyone or at any part of the body.
- Do not put your hand over the spray tip.
- Do not stop or deflect leaks with your hand, body, glove, or rag.



- Follow the **Pressure Relief Procedure** when you stop spraying and before cleaning. checking, or servicing equipment.
- Tighten all fluid connections before operating the equipment.



Check hoses and couplings daily. Replace worn or damaged parts immediately.



FIRE AND EXPLOSION HAZARD



Flammable fumes, such as solvent and paint fumes, in work area can ignite or explode. Paint or solvent flowing through the equipment can cause static sparking. To help prevent fire and explosion:



Use equipment only in well ventilated area.



- Eliminate all ignition sources; such as pilot lights, cigarettes, portable electric lamps, and plastic drop cloths (potential static sparking).
- Ground all equipment in the work area. See **Grounding** instructions.



Never spray or flush solvent at high pressure.



- Keep work area free of debris, including solvent, rags and gasoline.
- Do not plug or unplug power cords, or turn power or light switches on or off when flammable fumes are present.
- Use only grounded hoses.
- Hold gun firmly to side of grounded pail when triggering into pail. Do not use pail liners unless they are anti-static or conductive.
- Stop operation immediately if static sparking occurs or you feel a shock. Do not use equipment until you identify and correct the problem.
- Keep a working fire extinguisher in the work area.

Grounding

Grounding









The equipment must be grounded to reduce the risk of static sparking. Static sparking can cause fumes to ignite or explode. Grounding provides an escape wire for the electric current.

Spray Gun: ground through connection to a properly grounded fluid hose and pump.


Fluid Supply Container: follow local code.

Solvent Pails Used when Flushing: follow local code. Use only conductive metal pails, placed on a grounded surface. Do not place the pail on a nonconductive surface, such as paper or cardboard, which interrupts grounding continuity.




Fluid Hose: use only electrically conductive hoses with a maximum of 500 ft. (150 m) combined hose length to ensure grounding continuity. Check electrical resistances of hoses. If total resistance to ground exceeds 29 megohms, replace hose immediately.

Ground Metal Pails: Connect a ground wire to the pail by clamping one end to the pail and the other end to a ground such as a water pipe.



Maintain Grounding Continuity:

When flushing or relieving pressure, hold a metal part of the gun firmly against the side of a grounded metal pail, then trigger the gun.

Pressure Relief Procedure




Follow the Pressure Relief Procedure whenever you see this symbol.



This equipment stays pressurized until pressure is manually relieved. To help prevent serious injury from pressurized fluid, such as skin injection or splashed fluid, follow the **Pressure Relief Procedure** whenever sprayer is stopped and before sprayer is cleaned or checked, and before equipment is serviced.

- 1. Turn sprayer **OFF**.
- Engage the trigger lock. Always engage the trigger lock when sprayer is stopped to prevent the gun from being triggered accidentally.
- 3. Turn pressure control knob to lowest setting.
- Put drain tube into a waste pail and turn Prime/Spray valve in PRIME position (drain) to relieve pressure.
- Hold the gun firmly to a pail. Point gun into pail. Disengage the trigger lock and trigger the gun to relieve pressure.



- Engage the trigger lock.
- If you suspect the spray tip or hose is clogged or that pressure has not been fully relieved:
 - VERY SLOWLY loosen the tip guard retaining nut or the hose end coupling to relieve pressure gradually.
 - b. Loosen the nut or coupling completely.
 - c. Clear airless hose or spray tip obstruction. See Clear Spray Tip Clog, page 9.

Gun Trigger Lock










To prevent injury when the gun is not in use, always engage the gun's trigger lock if unit is being shut down or left unattended.











To avoid serious injury from skin injection do not put your hand in front of the spray tip when installing or removing the spray tip and tip guard.




To prevent spray tip leaks make certain spray tip and tip guard are installed properly.

- Relieve pressure. Follow the Pressure Relief Procedure, page 7.
- 2. Engage trigger lock (15).
- 3. Use spray tip (26) to align gasket and seal (24) in the tip guard (25).



- 4. Insert tip (26) in guard (25).
- Verify spray tip and tip guard parts are assembled in the order shown.



6. Install guard (25) over end of gun (1). Hand tighten retaining nut.

Connect Gun to Sprayer

Make sure sprayer is turned off and unplugged from power source. Refer to your sprayer instruction manual for priming and spray instructions.

- Attach supply hose to sprayer fluid outlet.
- Attach other end of supply hose to gun swivel (7). Use two wrenches (one on the swivel (7) and one on the hose), to tighten all connections securely.
- 3. Refer to your sprayer instruction manual for priming instructions.








Aligning Spray

- Relieve pressure. Follow the Pressure Relief Procedure, page 7.
- 2. Engage trigger lock (2).
- 3. Loosen guard retaining nut.
- 4. Align guard (25) horizontally to spray a horizontal pattern or vertically to spray a vertical pattern.



 Hand tighten guard (25) retaining nut when you have adjusted to desired setting.

Spraying

- 1. Disengage trigger lock (2).
- 2. Be sure the arrow shaped tip (26) faces forward (spray).
- Hold gun perpendicular and approximately 12 inches (304 mm) from surface. Move gun first, then pull gun trigger (13) to spray a test pattern.
- Slowly increase pump pressure until coverage is uniform and even(see sprayer instruction manual for additional information).

Clear Spray Tip Clog

In the event that particles or debris clog the spray tip, this gun is designed with a reversible spray tip that quickly and easily clears the particles without disassembling the sprayer.

- 1. Engage trigger lock (2).
- Rotate spray tip (26) to unclog position. Disengage trigger lock (2).
- 3. Trigger gun at waste area to clear cloq.

NOTE: If spray tip (26) is difficult to rotate when turning to the unclog position, perform **Pressure Relief Procedure**, page 7, then turn
Prime/Spray valve to spray position and repeat step 1.

- 4. Engage trigger lock (2).
- 5. Rotate spray tip (26) back to spray position.
- 6. Disengage trigger lock (2) and continue spraying.


Cleanup

Flush gun, clean filter (see Cleaning/Replacing Filter on page 12) and clean paint off the outside after each work shift. Store in a dry location. Refer to your sprayer manual for flushing instructions. Do not leave the gun or any parts in water or cleaning solvents.

NOTICE

To prevent damage to the gun parts, do not leave the gun or any parts, except the tip, in water or cleaning solvents. The gun is **NOT** compatible with cleaning solvents that contain methylene chloride.


Cleaning/Replacing Filter

A plugged filter reduces gun performance. Clean filter after each use.


- Relieve pressure. Follow the Pressure Relief Procedure, page 7.
- Disconnect fluid hose from gun at swivel (8).




3. Disconnect trigger guard (19) from gun retainer (10).



4. Unscrew handle (7) from gun (1).



5. Remove filter (5) through top of handle (7).



- 6. Inspect filter (5) for damage to the filter mesh. Replace the filter if the filter mesh has holes or voids.
- Clean filter (5). Use a soft brush to loosen and remove excess debris.
- Inspect handle bore (7) for damage. Replace the handle bore if it is corroded or pitted and check material for compability with aluminum.
- 9. Insert clean filter (5) into handle (7).
- 10. Reattach handle (7) to gun (1). Tighten securely.
- 11. Reconnect trigger guard (19) to guard retainer (10).

12. Engage trigger lock.



Replacing Needle

- Relieve pressure. Follow the Pressure Relief Procedure, page 7.
- 2. Engage trigger lock (2).
- 3. Remove tip (26) and guard (25) from gun (1).




- 4. Remove nut (17) and trigger pin (16).
- 5. Unscrew diffuser (15a) from front of gun (1).
- 6. Remove needle assembly (15b) through front of gun (1).
- 7. Use a soft brush to clean out internal passages of gun.
- 8. Grease o-rings of new needle using a non-silicon grease.

- Guide new needle (15b) through front of gun (1) making sure the flat sides (a) of the needle assembly face the sides of gun housing.
- Install diffuser (15a). Torque diffuser to 26-30 ft-lbs (35.25 - 43.38 N•m).
- 11. Replace pin (16) and nut (17).

Aligning Handle

If when tightened securely, handle no longer matches up with housing, realign handle.

- Relieve pressure. Follow the Pressure Relief Procedure, page 7.
- 2. Engage trigger lock (2).
- 3. Tighten handle (7) securely.
- 4. Loosen set screw (12) using a 1/8" allen wrench.
- 5. Rotate handle (7) so it is aligned with housing (1).
- 6. Tighten set screw (12) securely.
