

- 4. Connect other end of cellular module cable (2) to MCM (B) connector 14.
- 5. Place Graco InSite label (4) on front shroud as shown.




FIG. 1: Install Cellular Module

- 5. Place Graco Insite label (4) on front shroud as shown.




Fig. 2: Install Cellular Module


To register and activate the Graco InSite, go to www.GracoInSite.com, click on "InSite Login", then follow the instructions on the screen.


