

## Installation

See the drawing on page 3. The drawing shows the kit being installed on a Viscount pump and the 255143 Wall Bracket Kit, which are not included.

**NOTE:** Apply pipe sealant (19) to all non-swiveling threads.

- Flush the system before installing the kit.
- 2. Follow the **Pressure Relief Procedure** in your separate pump manual.
- 3. Install the BPR Bracket (2) to the mounting surface, using the screws (3), washers (4), and nuts (5).
- Install the back pressure regulator (1) on the BPR bracket (2), using the screws (18). Connect the 90° swivel union (6) and ball valve (7) to the regulator fluid inlet.
- 5. Install the pump onto the mounting surface with attaching hardware, as shown.
- 6. Pumps with Sealed or Open Wet Cup Lowers: Install the adapter (21), gasket (22), and clamp (23) at the pump fluid inlet, as shown in inset.
- 7. Install the bushing (8), nipple (9), tee (10), bushing (11), 3-way ball valve (12), and coupling (13) at the pump fluid inlet, as shown.
- 8. Install the straight swivel (15) in the open branch of the tee (10). Connect the hose (16) to the swivel, and the other end of the hose to a fluid suction tube (not included).
- Install the straight swivel (14) on the open branch of the 3-way valve (12). Connect the hose (17) to the swivel, and the other end of the hose to the swivel outlet of the back pressure regulator (1).
- Connect the fluid circulation return line (not included) to the ball valve (7) at the back pressure regulator fluid inlet.

# **Operation**

See your separate pump manual for general operating instructions. To adjust the back pressure regulator (1), see the separate regulator manual (308401) included with your kit.

Use the 3-way ball valve (12) to direct circulating fluid back to the pump inlet or to a drain tube connected to the coupling (13).


