

PREPARE EQUIPMENT FOR HMIINSTALLATION



- Shut off main circuit breaker before opening the ProMix V Control Box to avoid the risk of electric shock during the HMI installation.
- All electrical wiring must be done by a qualified electrician and comply with all local codes and regulations.
- Read the General Warnings in your operation manual 3B0203.
- 1. Shut off the main circuit breaker.
- Turn the main power switch OFF on the ProMix V Package Meter Proportioner.

INSTALL THE HMI

Properly install the ProMix V HMI equipment to ensure optimal performance during use.

- 1. Open the enclosure door of the ProMix V Package Meter Proportioner.
- 2. Clip the power over ethernet expansion module (3) onto the DIN rail located to the left of the power supply.




Figure 3-1: Install Expansion Module

3. Connect the red wire (7) and black wire (8) to the power over ethernet expansion module (3). Connect the other end of the red wire to the red terminal block inside the enclosure, and connect the other end of the black wire to the black terminal block inside the enclosure.




Figure 3-2: Connect Wires

4. Remove the original booth control bracket located on the right side of the ProMix V Package Meter Proportioner enclosure.




Figure 3-3: Remove Booth Control

- 5. Install the control mount bracket (9) onto the right side of the ProMix V Package Meter Proportioner enclosure using the screws (13).
- 6. Attach the HMI display (1) to the top of the control mount bracket (9) and secure using the screw (10) and nut (11).




Figure 3-4: Install HMI onto ProMix V

- 7. Route the ethernet cable (2) through the bottom of the ProMix V enclosure, and connect the cable to the top plug on the power over ethernet expansion module (3) labeled PoE.
- 8. Use the wire straps (5) to fasten the ethernet cable (2) along the right side of the enclosure.

9. Connect one end of the ethernet cable (14) to the X4 port in the controller in the enclosure, and connect the other end of the cable to the bottom plug on the power over ethernet expansion module (3) labeled Data.




Figure 3-5: HMI Connections

- 10. Close the enclosure door of the ProMix V PackageMeter Proportioner.
- 11. Turn the main power switch ON on the ProMix V Package Meter Proportioner.
- 12. Turn on the main circuit breaker.
- 13. The HMI will take approximately two and a half minutes to boot up after every power cycle. If the HMI does not boot up in the expected time frame, press the refresh button located on the top right of the HMI display (1).

NOTE:

If a longer ethernet cable (2) is needed, the replacement ethernet cable must be a shielded cable that is routed and secured in the same way described in the previous steps.

CLEAN THE HMI

Clean the HMI using a damp cloth and a suitable cleanser. Approved disinfectant wipes include products from Clorox[®], Lysol[®], Purell[®], Sani-Cloth[®], and Lonza (see full list for EPA Reg. Nos.). Avoid spraying liquids directly on the HMI and do not use abrasive materials or harsh chemicals such as high-concentration alcohols, strong solvents, acids, or steel-based tools.




Figure 6-1: ProMix V HMI Parts Diagram
