

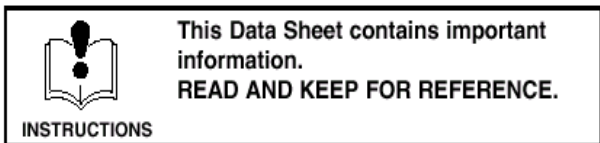

Base oil severely refined: Not carcinogenic in animal studies. Representative material passes IP-346, Modified Ames test, and/or other screening tests. Dermal and inhalation studies showed minimal effects; lung non-specific infiltration of immune cells, oil deposition and minimal granuloma formation. Not sensitizing in test animals.

Chlorinated waxes (long chain greater or equal to C-18): Not carcinogenic in animal feeding studies. High oral doses resulted in liver and kidney damage and changes in thyroid gland and blood. Did not cause mutations in vitro. No evidence of reproductive/developmental effects in animal studies.

Petroleum wax: Not carcinogenic in lifetime animal skin painting or oral feeding studies. Did not cause mutations in vitro.
